Before making any changes to your building or storefront such as signs, colors, exterior alterations, restorations reconstructions, demolitions or new construction- review by the Planning Board/Achitectural & Historic Review Board is required. Following review and compliance with local preservation law, the issuance of a Certificate of Appropriateness is necessary.

Always check with the Building Department first before starting any work on your building so as not to be in violation of local law. The Code Enforcement Officer, Dan Gardner, will be happy to guide you through the process and advise you!
